## HOW CAN SHORELINE'S MDCI CLIENT PROTECTION SCHEME HELP SHIOPWNERS ENHANCE THEIR COMPLIANCE PROFILE WITH NEW EU SUSTAINABILITY REGULATIONS?

### Overview: CSRD & CSDDD Compliance Challenges for the Shipping Industry

The EU's **Corporate Sustainability Reporting Directive (CSRD)** and **Corporate Sustainability Due Diligence Directive (CSDDD)** represent major regulatory shifts for the global shipping industry. These directives place accountability and transparency obligations on the largest shipowners, aiming to address failures in self-regulation, particularly regarding human rights and environmental standards in shipping.

### CSRD and CSDDD: What Should We Know?

The **CSDDD**, effective from July 2024, mandates that large shipowners, namely those with over 1,000 employees and a turnover exceeding EUR 450 million within the EU, embed robust due diligence measures into their operations and supply chain management. This requires them to actively mitigate human rights risks such as **forced labor, wage theft, abandonment and seafarer criminalization or forced detention**. Shipowners are now held accountable not only for their direct activities but also for the practices of their business partners within the supply chain.

The **CSRD** adds another layer of complexity, mandating that companies provide public reports on their **ESG** compliance, including how they mitigate risks and threats to the human rights of their employees and the environment. Non-compliance risks hefty financial penalties and reputational damage, as non-compliance will be made public.

## The New Reality for the Shipping Industry

Historically, the shipping industry has relied on self-regulation and voluntary compliance. However, the increasing frequency of issues like seafarer abandonment, wage theft and poor working conditions demonstrates that this approach has proven insufficient. In response, the **CSDDD** requires shipowners to be accountable not only for their own operations but also for the practices of their business partners, such as **manning agencies, ship management companies and charterers**. All entities within the supply chain must adhere to the same operational standards and best practices, ensuring a more consistent approach to seafarer welfare and environmental compliance.
